## 1. ACCOMMODATION

Four thatched chalets with 4 single beds each, shower and toilet, including bedding but no towels. Fully equipped kitchen with cutlery, fridge, freezer, etc. as well as a lapa with barbeque/braai facilities.

## 2. ARRIVAL AND DEPARTURE

- 2.1 Bookings should be for a minimum of 4 hunters for a minimum of 3 nights i.e. Thursday, Friday & Saturday nights.

## 3. PRICES INCLUDE THE FOLLOWING

- 3.1 A hunting guide with radio communication for a maximum of 6 hunters per hunting session.
- 3.2 Transport of hunters to and from pre-arranged collecting points, and carcass to the butchery.
- 3.3 Skinning of the game and transferring to the cold storage room.
- 3.4 Fully equipped butchery. Bring own knives if you intend to process your own meat.
- 3.5 Please utilise firewood responsibly and sparingly.
- 3.6 Cleaning of chalets and kitchen once a day.
- 3.7 Exclusive hunting opportunity: No sharing with other groups in the camp and the field.
- 3.8 We propose that an amount of R100, 00 per hunter should be contributed to the Guide Fund. This money should be handed to the Farm Manager, at the end of your stay, by the person who made the reservation. This money will be shared equally between the guides, the slaughterers and the domestic worker.

## 4. GENERAL RULES

- 4.1 Admission to the farms Kareelaagte and Buffelskraal is at your own risk and no liability will be taken for any loss, damage, illness, injuries or costs consequent upon the aforementioned.
- 4.2 Right of admission reserved.

- 4.3 The person making the booking will be liable for any damages, and must see to it that hunters and visitors obey the rules.
- 4.4 Definition of a hunter is any person that enters into the hunting field, this person will be viewed as a hunter for the full duration of his/her stay.
- 4.5 For confirmation of bookings, a deposit is payable and the outstanding amount is payable in cash or with a bank guaranteed cheque before departure. Due to poor cellphone coverage in the area electronic funds transfers (EFT) is not always possible.
- 4.6 No private vehicles will be allowed in the field. Speed limit is 40 km/h.
- 4.7 No alcohol allowed while hunting - neither in the field nor on the vehicle.
- 4.8 No littering in the field or at the camp is permitted.
- 4.9 In terms of Article 120 of the Firearm Act, we prefer that each hunter will be in possession of his own hunting rifle/s which he/she has a valid license for.
- 4.10 Responsible handling of rifles at all times to avoid shooting accidents. No loaded rifles will be allowed on any vehicle. Persons infringing any safety rules will be charged a double day tariff.
- 4.11 No caliber rifle smaller than .270 will be allowed for hunting.
- 4.12 Rifles must be locked in the designated safe - the group-leader or farm manager will be in the possession of the keys.
- 4.13 No hunting from vehicles, during dusk or night time, near waterholes or at the boundary fences will be allowed.
- 4.14 Prohibited hunting within 500 meters of the camp and dwellings.
- 4.15 Determining of the specie, gender, size and trophy dimensions is your own responsibility and not the guide's responsibility.
- 4.16 Wounded game will be regarded as hunted game and will therefore be charged at full-price.
- 4.17 In the case of a shot fired at a specie and there is no evidence of it being wounded, a 20% charge of the value of the specie will be liable.
- 4.18 In the case of a hunter wounding an animal, he will only be allowed to continue to hunt after the wounded animal is found.
- 4.19 No hunting without a hunting guide.
- 4.20 No alcohol should be given to the Guides.

- 4.21 When smoking in the field please be very aware to prevent starting a veld fire.
- 4.22 In the case of a hunter being guilty of unethical hunting, misbehavior, breaking of rules or dangerous handling of weapons he will be asked by the manager to leave the farm.
- 4.23 Rifles will be locked up at night. No night drives without the permission of the manager.
- 4.24 Game species not listed may not be hunted as well as the following:

- 4.25 A fine of R5 000, 00 will be payable if any of the species mentioned in par 4.24 are being hunted, expect for a Njala where the fine will be R10 000,00 and for a Buffalo the penalty would be R500 000,00.
- 4.26 The hunting of zebras will be limited to 2 zebras per group.
